**VOCATIONAL GRANT PROGRAM APPLICATION
INSTRUCTIONS**

The application and all letters should be bound on the left side with sufficient margin on the left border for readability. The application should include:

- A personal letter summarizing activities, accomplishments, needs and objectives, which the applicant thinks qualifies them for a grant and outlines their career goals.
 - Include at least one (1) and not more than three (3) letters of endorsement from responsible persons, not related to the applicant, who can give a worthwhile opinion of the character, industry, disposition and general worthiness of the applicant.
 - You may include any other information which you feel will be helpful in judging your eligibility for a grant.

This grant is for one year and is not renewable, but grant recipients are eligible to apply again.

All applicants must be a citizen of the United States of America on the date the application is signed.

Open to all pursuing vocational training or certification regardless of age

Judging will be based on, but is not limited to the following:

1. Application completeness
2. Applicant's program is clearly stated on the application
3. Information provided in the personal letter included with the application
4. Letters of endorsement included with the application
5. Any information provided by the applicant that he/she feels will be helpful in judging their worthiness for a grant.

Do not apply if you are planning to pursue an Associate Degree course which is a stepping stone to a 4 year diploma. An eligible program is one that after a two year period of study or a training program leading to certification a student may become gainfully employed in his/her chosen vocational career.

The application deadline is April 30, 2021.
